MARATHON:

All classes except Class 1 will complete a 2-section marathon course with Transfer and 5 MO's (approx. 14 kms). The course is mostly flat. The marathon obstacles can be inspected from 9am Saturday.

CONES:

Will be run as a fault competition, wheel width as per 'Rules for **Australian Carriage Driving Society** Combined Driving Events'. Cones course may contain a bridge or water. Each competitor's wheel width will be measured after the cones competition.

You MUST include the wheel width you will be using in competition A and C on the entry form.

ENTRY FEE: \$90 (25% discount for our competitors travelling further than 300km one way i.e \$67.50) Juniors drivers free entry

CAMPING: Camping facilities available on grounds and are included in your entry fee.

Non-competitors - \$10.

Powered sites are limited. Access to hot showers, toilets, etc.

YARDS: No yards will be allocated, first in best dressed.

CONDITIONS OF ENTRY

1. All classes will be judged under the current 'Rules for **Australian Carriage Driving Society** Combined Driving Events' effective 15 October 2020 and any conditions included in this schedule
2. Drivers must be full ACDS members. Club Receipts or current Membership Cards must be produced if requested.
3. *All horses must be registered with the ACDS. If you have an unregistered horse, you will need to complete a registration form and send it to the horse registrar.*
4. All competitors compete at their own risk. The Range Carriage Club Inc., the event organising committee and all landholders involved, accept no responsibility for loss or damage to horses, owners, drivers, grooms, spectators, equipment, or any other person or property whatsoever, whilst at or near the venue, during the course of this event.
5. The wearing of protective headgear, suitable for equestrian purposes is mandatory in all sections of the marathon as per article 928.2.2 of the 'Rules for **Australian Carriage Driving Society** Combined Driving Events'
6. All junior drivers between 12 and 16 years must be accompanied by a capable adult (adult must be a full ACDS member) in all phases of the competition. Whenever a junior is in a vehicle, they must be wearing a helmet suitable for equestrian use as per the 'Rules for **Australian Carriage Driving Society** Combined Driving Events', whether they are members or non-members. Junior grooms must be min.10yrs old for singles & min. 14yrs old for multiplies.
7. Whenever a horse is harnessed to a vehicle, an ACDS member must be in the vehicle holding the reins with contact.
8. Appeals, together with \$50, are to be lodged in writing within 30 minutes of the scores being posted for each phase. Money may be refunded unless, in the opinion of the Appeals Committee, the appeal is found to be frivolous.
9. The organisers reserve the right to: Alter any advertised times; Refuse any entry, with or without stating the reason; Measure any horse or pony upon discretion reallocate a competitor to the appropriate class.
10. The event will be run on time. Any competitor late for a scheduled starting time may be awarded time penalties. In the event of an accident, or any other occurrence beyond the control of the competitor, contact the Secretary to arrange an alternate starting time.
11. Organisers reserve the right to penalise competitors for unsafe practices.
12. Dogs must be on a leash at all times, owners must clean up after their dogs.
13. No vehicle with a wheel width less than 125cm will be accepted.
14. Drivers with non ACDS grooms need to complete the appropriate form.

1. If required before movement, all horse/s will be shampooed, rinsed and allowed to dry, and their hooves will be picked clean of all solid material and washed.
2. All vehicles and equipment accompanying the horse/s should be in a clean condition at the start of travel and on entry to the above mentioned event.
3. The information contained in this Horse Health Declaration is true and correct to the best of my knowledge.
4. I agree to abide by all conditions and directions of the Event Committee/Organisers and rules and regulations of the ACDS.
5. In the event of horse movement restrictions, each participant will be responsible for the care, maintenance and cost of their horse/s including feeding and watering.
6. All appropriate permits and waybills have been completed and accompany the horse/s.
7. I acknowledge that failure to comply with the above may result in refusal of entry to the venue, disqualification or other disciplinary action as decided by the Event Committee/ACDSQB.
